The entry-Level Public Safety Examination Process provides candidates with job opportunities in a wide variety of job titles such as Sheriff's Officer and other public safety related titles. In order to be considered for employment in an entry-level law enforcement position, candidates must pass a written exam called the Law Enforcement Examination (LEE). Those who pass will remain in the eligible pool for two years. The pool of eligible candidates that result from the LEE will be used to fill positions for law enforcement titles in all Civil Service jurisdictions.

Law Enforcement Division

Special Services Unit

K-9 Squad

The Salem County Sheriff's Office currently has 5 dogs trained in Bomb Detection, Patrol and Narcotics. Our K9's assist with detecting and apprehending fleeing or hidden suspects, high risk stops and searches, and searching for bombs, narcotics, articles, and lost persons. They also conduct public demonstrations.



Warrant Squad

Officers in the Warrant Squad develop information on the location of wanted persons and work with other departments in executing writs, conducting raids, undercover operations and extraditions.

Civil Processes

Processes are documents produced in court which need to be served or matters to be executed. Sheriff's Officers serve Child Support, Criminal and Superior Court Warrants and conduct weapons seizures. They may also help with evictions, foreclosures and Sheriff Sales.



Traffic Enforcement

Supplementing the NJ State Police and other local law enforcement agencies, Salem County Sheriff's Officers assist by patrolling county roads. They may issue warnings or summons for traffic violations. Officers are also trained in radar, alcotest and field sobriety, to improve the safety of our roadways.



Bicycle Patrol

The Bicycle Patrol covers the entire county, making use of the maneuverability to patrol those areas that are more difficult to access with a regular police vehicle. They can quickly make their way through parking lots, between buildings down alleys and sidewalks.



Courthouse Services Unit

Transportation Squad

Salem County Sheriff's Officers transport Federal, State, and County inmates to Superior Court, Municipal Court, hospitals, doctors, funerals and programs.



Courthouse Security Squad

The Courthouse Security Squad is in charge of the security of the courthouse. The entrance to the courthouse has metal detectors and x-ray machines. Court room security is provided for Criminal, Civil and Family Courts.
